During his tenure, the organization and community supported several industrial attraction projects, numerous industrial expansion projects, the expansion of the Putnam County Regional Airport, and a wide range of community development projects.

Mr. Dory started his career in 1983 as the executive director of Main Street Greencastle, a local downtown revitalization organization, and the western regional director of Indiana Landmarks. In 1990, he joined the State of Indiana as the director of the Indiana Main Street Program.

Since becoming mayor, with the support of staff, the city council, various city boards, and community organizations, the city has obtained several grants for road projects, implemented an on-line permitting system, implemented a new road maintenance program, implemented several park improvement projects, and supported three housing development projects.

Mr. Dory holds a Bachelors of Environmental Design from Miami University and a Masters in Urban and Regional Planning from the University of Illinois. Mr. Dory has served on numerous not-for-profit boards over the years including leadership roles. He served as president of the Indiana Economic Development Association and the Greencastle Rotary Club. Mr. Dory holds several professional certifications such as American Institute of Certified Planners and Economic Development Finance Professional.

Mr. Dory's wife, Kathryn, recently retired from teaching middle school band and choir at Greencastle Middle School. They have two children who are now pursuing their own professional careers.

How to "Do Mental Health at the Y"	This interactive workshop will highlight the evolution of the Mental Health Revolution at the Y. Participants will leave with a wealth of tools and resources to help build a culture of mental health at your local Y.
Dinner Table Resilience	Resilience is our ability to thrive, adapt, and cope despite tough and stressful times. We build resilience through intentional actions that promote connection to others, ourselves, and effective coping skills. This interactive workshop will introduce the Dinner Table Resilience series and offer opportunities to consider how to build resilience in your local Y, community, and around your own dinner table.
Local Advocacy: Engaging with and Developing Relationships with your Local Elected Officials	This presentation will touch on the unique relationship between advocating for issues and developing productive working relationships with local elected officials. This is based on the speaker's experience both as an advocate for the YMCA and a local elected official. He will discuss the most effective ways to reach out and make an impression on your local officials and how to build working relationships based on issues.
Serving with intentionality – how can we stay relevant in the future?	YMCAs around the country are constantly adapting services in order to create more welcoming environments for the communities they serve. The latest census offers insight into current demographic realities in the U.S., and organizations like the Y are at the forefront. How do we begin preparing for the future of Y service?
